#### JOB SUMMARY:

Under the direction of an assigned elementary school Principal, provide supervision for students during the recess or lunch periods; set-up and take-down playground equipment; monitor designated areas on an assigned school campus in accordance with organizational and school policy; train and guide campus student supervisors; provide effective behavioral learning experiences for students and promote problem solving skills.

### ESSENTIAL DUTIES AND RESPONSIBILITIES:

- Engage and oversee children on the playground during recess and lunch periods; engage and organize students into structured exercises, including team sports, recreational activities and a variety of playground games; ensure physical education staff are provided with games and recreational material to teach physical education classes.
- Set-up, take-down and store physical education and playground equipment, materials and sports accessories for Kindergarten and First-Fifth grade students; set-up playground areas for football, soccer and baseball games; put-up volleyball net.
- Ensure playground equipment is safe and usable; inventory and order playground equipment as needed; make minor repairs on playground equipment as needed.
- Organize, teach, supervise and referee playground activities; assist students in the resolution of problems arising on the playground; communicate more serious issues and consistently inappropriate behavior to teachers and assigned school Principal; inspect, review and monitor campus to deter and prevent inappropriate behaviors and eliminate potential safety hazards; complete disciplinary and accident reports for students, as required.
- Utilize peaceful playground procedures with students; train, guide and schedule campus student supervisors and assist with needed equipment and related items.
- Organize and maintain a variety of schedules including for lunch and Heat/Rainy days.
- Monitor and lead student activities in lunch areas, classrooms on rainy days, play areas, restrooms and in areas adjacent
  to the school buildings; maintain order and proper discipline on the playground, in the halls or at other campus locations
  as assigned; advise students and others regarding violation of rules and regulations.
- Assist ill or injured student or students; administer basic first aid necessary; request for emergency medical services as needed.
- Communicate with administrators, teachers, personnel and students to, resolve issues and conflicts and exchange information.
- Assist teachers with Running Club activities; order student incentive program items.
- Attend training on peaceful playground procedures.

Perform related duties as assigned.

- Typical playground games and activities.
- Organizational and school emergency procedures including fire drills, intruder on campus and others.
- Basic first aid.

- Inspect, review and monitor campus to deter and prevent inappropriate behaviors and eliminate potential safety hazards.
- Enforce campus rules and regulations.
- Communicate effectively both orally and in writing.
- Understand and follow oral and written instructions.
- Establish and maintain cooperative and effective working relationships with others.
- Monitor students and respond to situations in a quick and timely manner.

### **Work Environment:**

- Playground/Outdoor work environment.
- Constant interruptions.
- Exposure to adverse weather conditions, including rain, wind, dust and heat.

- Seeing to monitor student activities.
- Hearing and speaking to exchange information.
- Bending at the waist, kneeling or crouching to assist students.
- Reaching overhead, above the shoulders and horizontally to reach playground equipment or supplies.
