**SAN DIEGO COUNTY COMMITTEE ON SCHOOL DISTRICT ORGANIZATION
GUIDELINES FOR PUBLIC HEARING**

**PROPOSAL FOR THE ESTABLISHMENT OF TRUSTEE AREAS IN THE LAKESIDE UNION
HIGH SCHOOL DISTRICT AND FOR THE ELECTION OF ONE MEMBER OF THE
GOVERNING BOARD RESIDING IN EACH TRUSTEE AREA BY THE REGISTERED
VOTERS IN THAT TRUSTEE AREA**

The recording secretary will record the entire meeting.

Prior to the opening of the public hearing, attendees will be asked to provide their names and addresses on an attendance sheet. The completion of this document is voluntary, and all persons may attend the meeting regardless of whether they sign the attendance sheet.

Persons wishing to address the San Diego County Board of Education must complete a blue speaker registration card, indicating whether they wish to support or oppose the proposal. Alternatively, a pink information card may be used to submit written comments on the proposal and/or to indicate support or opposition.

1. The President of the County Board of Education, acting as the County Committee on School District Organization (County Committee), shall announce the opening of the public hearing and ask all those present and desiring to speak for or against the proposal to turn in completed blue speaker cards to the recording secretary. Speaker cards also will be collected during the hearing.
2. The order of the speakers will be as follows:
 - Spokesperson(s) for the district
 - Individual speakers called from speaker cards in the order submitted
3. The designated spokesperson(s) for the school district shall have 10 minutes for an initial presentation.
4. Individual speakers will be called in the order speaker cards are submitted.
5. Individual speakers shall have up to 3 minutes to present testimony. The Board President may reduce the time allotted to each speaker based upon the number of requests to speak. Speakers shall direct all testimony to the County Committee. Individual speakers will be asked to limit remarks to new information regarding the proposal and will not be permitted to cede any of their allotted time to another speaker.
6. County Committee members may address questions through the President to any speaker.
7. When all persons desiring to speak on the proposals have been heard, the President shall declare the public hearing closed.
8. The County Committee on School District Organization may take action on the proposal to establish by-trustee area elections or the trustee area plan at the public hearing. The proposal may be approved or disapproved at this meeting or a future date to be determined by the County Committee.
