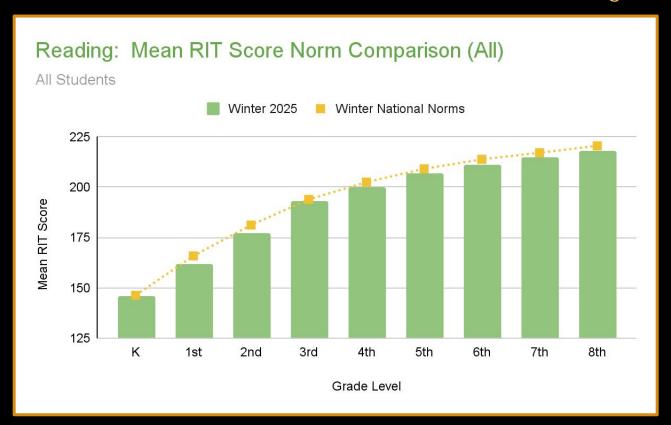

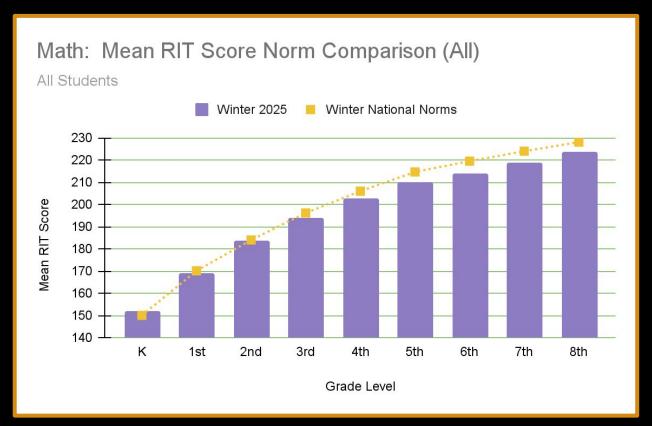

MAP Scores for ALL students: Math

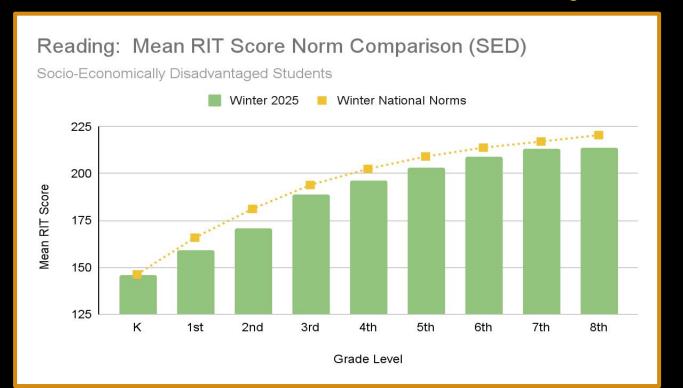

MAP Scores for Socioeconomically Disadvantaged students: ELA

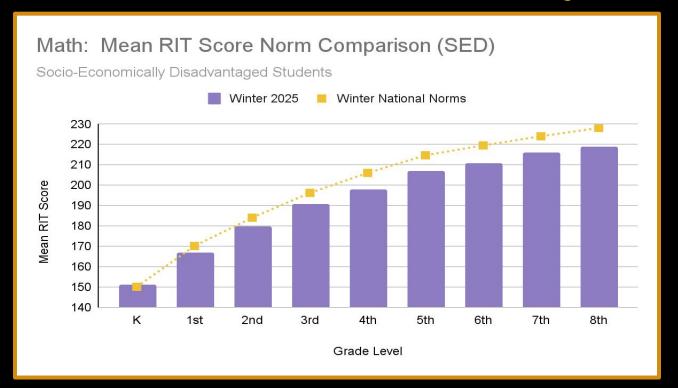

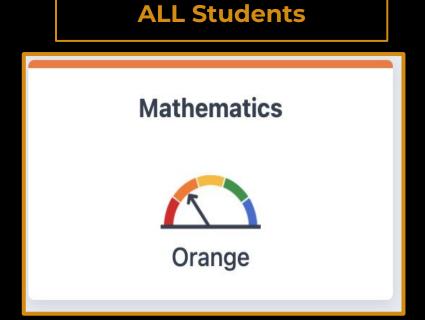

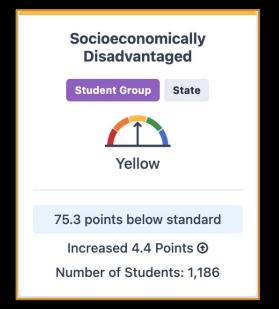




CAASPP Scores Math 2024: Our goal is GREEN

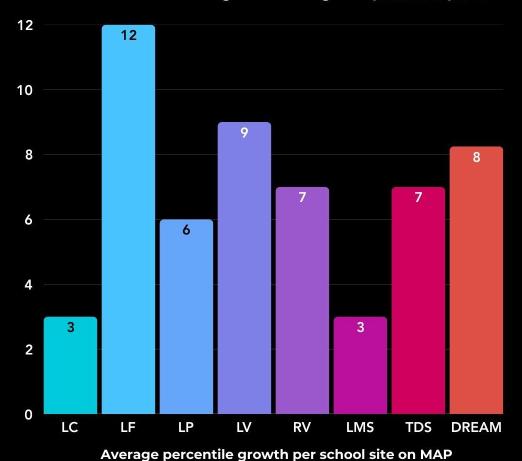

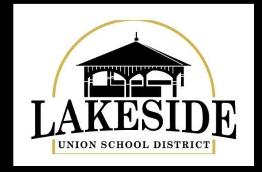
Intervention classes are provided before and/or after school, 3-days per week for 45 minutes each.

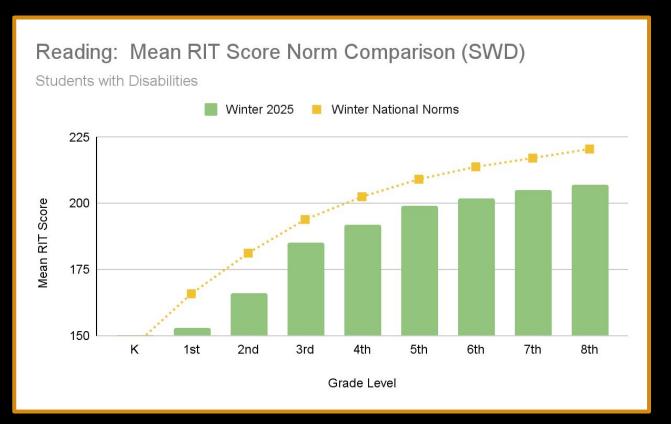

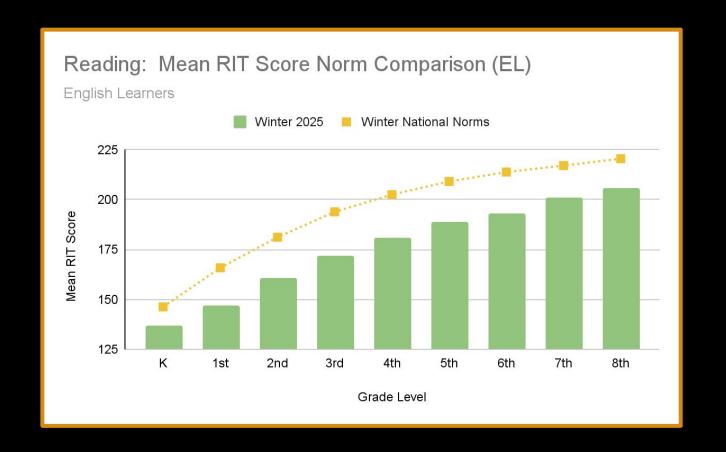

MAP Scores ELA: Students with Disabilities



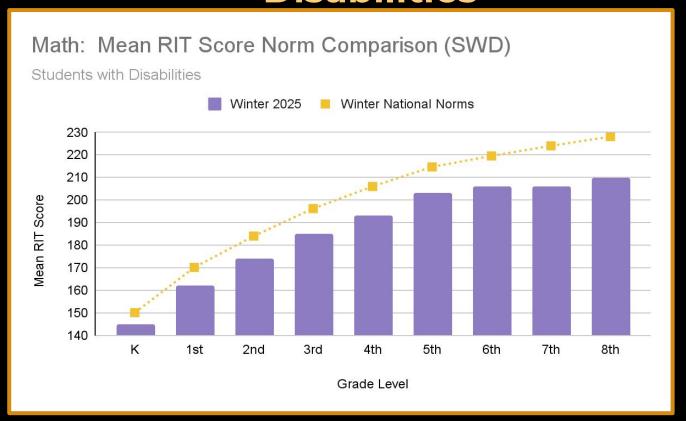


MAP Scores ELA: English Learners



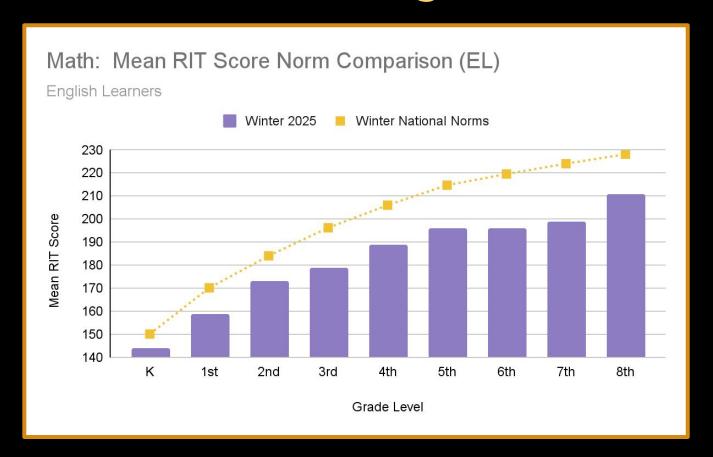


MAP Scores Math: Students with Disabilities



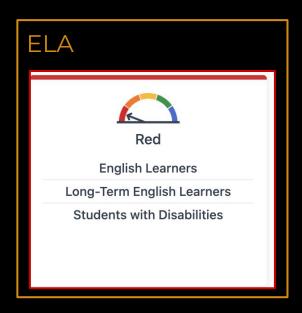


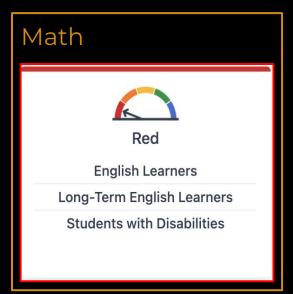
MAP Scores Math: English Learners

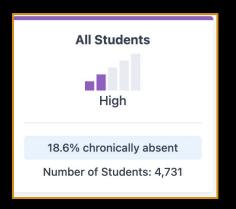

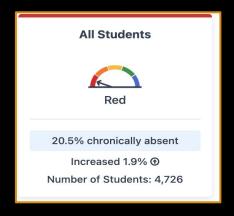

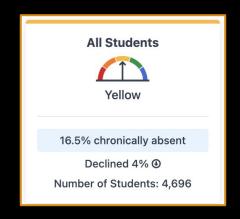




Chronic Absenteeism Rates - CA Dashboard: Goal is no more than 10% CA

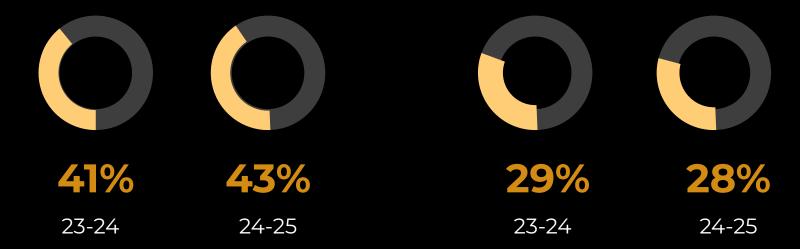

Percentage of **students** reporting meaningful participation at school. (Goal is 85%)

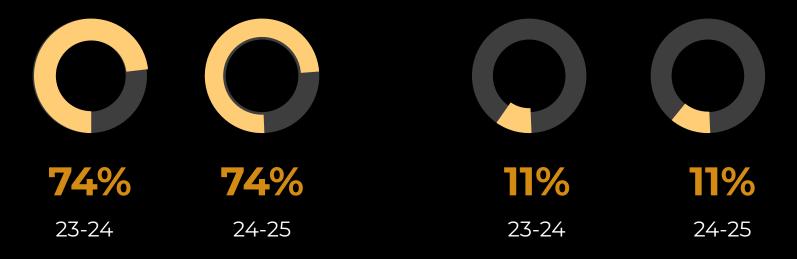

Percentage of **students** reporting receiving social emotional learning supports at school (Goal is 85%)

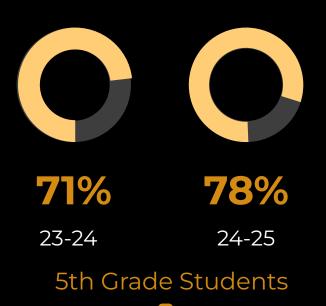


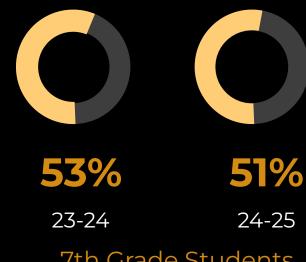

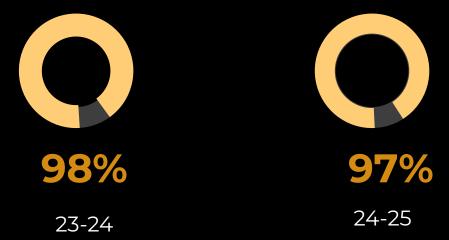
SAFETY: Percentage of **students** reporting they feel safe at school (Goal is 85%).







Percentage of **staff** reporting that school is a supportive and inviting place for their students to learn. (Goal is 85%)



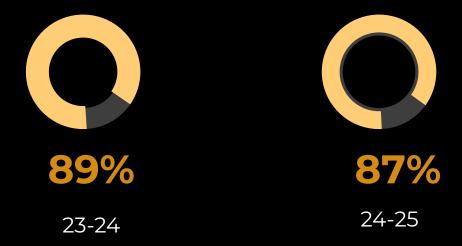


Percentage of **staff** reporting that their work environment is a supportive and inviting place to work. (Goal is 85%)

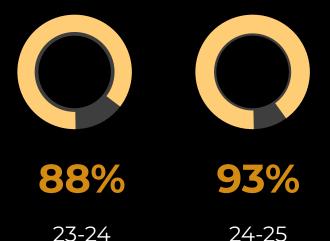

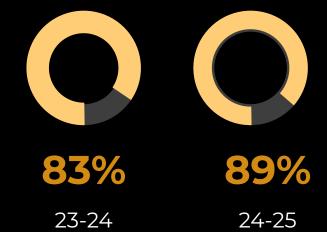




Percentage of **parents** reporting that school promotes academic success for all students. (Goal is 85%)

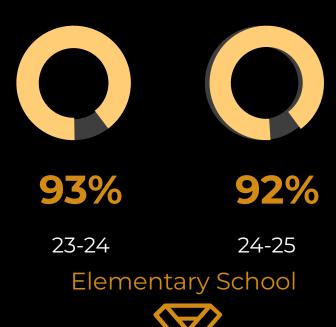


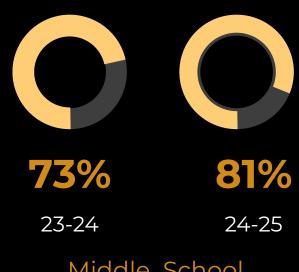

LCAP Goal 3

Student Support

Student behavior and engagement including counseling and mental health supports for students.

Highlight: School Counselor Impact

Tier 1

 400+ whole classroom lessons taught

Tier 2

- 50+ small groups of students received instruction in emotional regulation, friendship skills, conflict resolution, coping skills, building confidence and responsibility
- 100+ students had daily check ins with a trusted adult

Tier 3

- 100+ one-on-one sessions with the counselor
- Parent contacts and referrals to services
